Job Requirements

- Must be proficient in the use of handheld and personal computers and be familiar with basic Windows programs such as Word, Excel and Access. Proficiency with GIS & Forest Inventory programs such as FPS or SuperAce is desirable.
- Must understand basic forestry principles such as tree identification, classification of streams and wetlands, and harvesting techniques. Familiarity with Oregon and Washington State Forest Practice Act is desirable.
- This is a Field position with 80% of work hours performed in an outdoors setting that requires 10-15% overnight travel to various client properties in Washington and Oregon.
- Must be able to operate basic forestry equipment such as a 4 X 4 pickup, GPS equipment, hand compass, clinometer, relaskop and brushing tools.
- Must be physically fit and able to work independently in difficult terrain.

Job Description

- Performs stand exams. Inventories timber stands to determine volume and grades. Determines appropriate sampling intensities. Assesses value of timber.
- Conducts silvicultural surveys. Plans and performs compliance on tree planting, conifer release and precommercial thinning projects.
- Plans and prepares timber sales including field location of boundaries and roads. Develops prescriptions for Commercial thinning harvests. Identifies appropriate logging systems. Prepares permits, maps and exhibits as needed.
- Researches and recommends solutions to identify and treat various forest health issues. Identifies noxious weed issues. Prepares prescriptions and works with silvicultural contractors to implement plans.
- Assists with client meetings and tours. Attends training.
